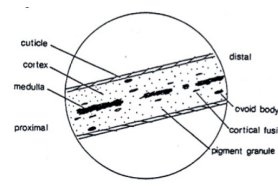
### Scenario



Police have been investigating a number of 'chop shops' which they believe are linked. Panels have been collected from four locations.

The participant laboratory is requested to examine the panels to determine if any of them match.

Participants will be provided with four panels, each collected from one of the locations.



A blanket was used to wrap a body. Tape lifts were taken of the blanket. The participant laboratory will be asked to examine the tape lifts to determine if any hairs can be detected and, if so, whether these hairs can provide any information to the investigators.

Participants will be provided with a tape lift from the blanket.



During a home invasion, an altercation occurred which included the home occupants. The occupants were injured and bled, it is thought that their assailants also bled.

Participants will be provided with samples of the carpet.



Police have obtained information regarding a missing person. Upon attendance at the individual's residence a number of bloodstains are detected. The stains are identified as human blood using confirmatory tests. The participant laboratory is requested to provide the investigator with any information regarding the sequence of events leading to the pattern of stains detected.

Participants will be provided with a number of high quality scaled colour photographs.



Fraud investigators have collected a number of documents from a number of locations.

Participants will be provided with a number of machine generated documents and asked to examine the documents for authenticity and also to determine if any have a common source.



Items collected from crime have been submitted for fingerprinting. The participant laboratory will be asked to examine the items for any latent fingerprint present. Enhancement techniques may be required. Any prints collected will need to be compared to comparison prints supplied.

Participants will be provided with a number of paper based items.
